There are parents, children and vulnerable adults in Harford County who need our help. As members of the Citizen’s Advisory Board for the Harford County Department of Social Services (HCDSS) we are keenly reminded of this when we review the growing statistics of children in foster care, and adults who are neglected or abused. We want to help reduce the trauma and stress associated with these unfortunate circumstances. The Family Assistance Fund is a board initiative that raises money to cover needed expenses that are NOT part of the DSS operating budget.
